TSBT CENTAUR 100 CLUB RULES

The TSBT's aim is to support restoration work on CENTAUR.

1. The fee for membership of the Thames Sailing Barge Trust 'Centaur 100 Club' shall be £12 per annum payable in advance per share.
2. If you are purchasing a number of shares, you may use a Banker's Standing Order to be set up for £1 per month, per share i.e. for 5 shares, £5 per month.
3. Or you may make a one-off payment for each share. We prefer payment by BACs please, but cheques are acceptable.
4. No member may be permitted to participate in the draw except after payment.
5. Membership shall be limited to 100 fully paid members, over 18 years of age. Any number of chances may be purchased.
6. There will be a maximum of 6 draws annually.
7. Winners will be announced in the Golden Chaffcutter.
8. Prizes to be paid as follows: 1st £50, 2nd £20, 3rd £10
9. No prize will be paid to any member, other than the member holding the winning membership share number.
10. Draws will take place at a Trust Committee Meeting or other Trust gathering such as Working Parties.
11. In the event that the membership of the 100 Club is less than 100 members, the Trust shall be entitled to reduce the amounts of prizes or number of draws.
12. In the event that the demand for membership exceeds 100, additional members can be admitted with a proportionate increase in prize money.
13. **The minimum period of membership is one year.**
